



The fifth NGO Fair - Macedonian Civil Society Forum took place

(total of 228 civic rganizations, of which 19 om abroad, presented nemselves at the NG articipants and visitors had the opportunity to attend around 60 panels, round tables, educational sessions as well as socio-cultural events. Around 8700 citizens ted the Fair this year.

The central event of the civil sector, the Fifth NGO Fair - Macedonian Civil Society Forum, this year took place between 9 to 11th December 2005, at the Skopje Fair. This year the motto of the Fair was "The center is where you are!" which reflected the topic in focus - decentralization. Focus country for this year's NGO Fair was Albania. The Fair was organized by the Macedonian Center for International Cooperation. At the opening ceremony of the Fifth NGO Fair - Macedonian Civil Society Forum, the Special Envoy of the European Union and Head of the Delegation of the European Union to Skopje Mr. Erwan Fouéré addressed the present: "A developed civil sector is an indicator of healthy society, the civil sector is a partner of the government in the implementation of the European regulations and on Macedonia's path to Europe, however the civil sector is also a sector that is

successful in the struggle for human rights, in the fight for improving social conditions in the country, a sector which has successes in the field of improving education in Macedonia". stressed Fouere. Talking about decentralization, at the opening of the NGO Fair, Ace Kocevski the Mayor of Veles gave a speech. "With the process of decentralization the state will renounce part of its power but the citizens need to accept that they are power and a decisive factor", Koceyski pointed out. Those present were addressed also by Ligor Nikola, president of the Association

for Albanian-Macedonian friendship from Tirana, who emphasized the need for implementing the agreements for mutual cooperation between Macedonia and Albania. Saso Klekovski, Executive Director of the Macedonian Center for International Cooperation in his address, reminded the present, that the campaign "Zero tolerance for corruption" and the privatization of the Electrical Company of Macedonia are simultaneously beginming. "These events are a great challenge for the civil sector as well, to be actively involved in these processes and to take action", underlined Klekovski who also added that it should not be overlooked that 2005 is the year of the start of the Roma Decade 2005-2015, as well as that we are half-way towards proposing the first Law on citizens initiative. At the opening of the NGO Fair, besides representatives from the civil organizations, the business sector, diplomatic corps and state institutions as well as the president of the Republic of Macedonia, Mr. Branko Crvenkovski were present.

What after December 15th – was the central issue of the panel "Waiting for the EU response – 5 days before" which was organized by the Delegation of the European Commission and the Macedonian Center for International Cooperation. "A year ago we had doubts whether our administration could respond to the EU questionnaire and whether it

is qualified enough. Now we can state that some doubts where justified and some not", stated at the panel Radmila Sekerinska. "The aspiration towards EU membership is very noble", stated Erwan Fouéré, Special Envoy of the EU and Head of the Delegation of the European Union to Skopje. Civil society and civic initiatives are very important in the EU, hence the cooperation of the government and the civil sector is one of the crucial issues", Fouéré emphasized.

Around 8700 citizens visited the NGO Fair, 1000 of which came from other cities in Macedonia with the organized transport, subsidized by MCIC. "I saw almost everything. I think it is quite interesting, there are many different organizations and various topics", Urtike Eckman, a visitor to the Fair said. "This is my first NGO Fair in Macedonia and generally. I do not have any special interest; I just came to see the

place and to see their activities. We visited one socio-cultural event, it was very good. I am pleased to have spent a day here. We got many new ideas which I believe will be developed in our organization", he said.

FORUM

In the forum part, organizations and visitors were offered sixty events including panels, round tables, educational sessions, presentations and promotions. Despite the fact that the largest numbers of panels were dedicated to the topic in focus - decentralization, still other topics were also addressed. Those interested could participate in the panels related to citizen participation in the decision-making process, at the panel discussed the reforms and whether in Macedonià exists the willpower to implement them. At this Fair topics addressing awareness among women for early detection of breast cancer, were also present

The forum events at this year's fair were visited by 1060 citizens. Organizations from the region had the opportunity to present themselves in the forum also. Those interested could see the presentation of an organization from Albania and from Kyrgyzstan, to participate in the workshop which had guests from Albania, Croatia, Bosnia and Herzegovina, Serbia and Montenegro and Turkey.
