## Mainstreaming Gender in Debt and Resource Development Management Debt Management Series 3, Dinesh Dodhia and Tina Johnson

The Commonwealth Secretariat has prepared this Handbook to enrich the information available to debt managers, gender advocates and other development practitioners and to make a contribution on the way forward with this topical issue. The Handbook highlights the linkages between debt and gender and discusses policies and action taken by international agencies and bilateral donors to promote and integrate gender issues in the provision of gender assistance. It suggests effective and practical ways through which developing country governments can integrate gender quality considerations in their debt and development resource management. The Handbook makes recommendations for debt recording systems, such as CS-DRMS, to better track the impact of debt and externally funded programmes on gender perspectives.




#### The GMS Toolkit

This volume brings together six case studies: three focusing on linking local producers with global markets; and three focusing on improving conditions of wage workers and outworkers already integrated into export markets through global value chains. Producer case studies are: a cocoa cooperative in Ghana which co-owns a UK chocolate company; family-based cooperatives in Samoa producing organic virgin coconut oil; new small cashew enterprises in Mozambique. Wage worker case studies are: women in the South African fruits industry; women in Bangladesh in the ready-made garment industry; women in newly created technology-enabled industries in India. Each case study presents concrete examples of shifting the balance to help the working poor benefit from globalization.

This book promotes a multi-faceted approach to conflict transformation that includes gender and youth, political, human rights and development perspectives. The book will help Commonwealth countries find long-term solutions to violent conflict. It addresses the structural causes, and argues that the participation of the whole of civil society is essential for building sustainable peace. The book considers: the peace table and peace agreements; human rights violations; truth and reconciliation commissions; international criminal tribunals; post-violence reconstruction and peace education.

This book brings together the papers commissioned for a Pan-Commonwealth Expert Group Meeting on Gender and Human Rights which took place at the Commonwealth Secretariat in London in February 2004. They address a wide range of issues, including the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW), gender-based violence, culture and the law, indigenous peoples, trafficking and migration, land and property rights, diversity and a life cycle approach to gender and human rights. The contributors include government policy makers, judges, lawyers, academics, representatives of civil society organisations and specialists from multilateral agencies including the Commonwealth Secretariat.


In this book, the authors highlight the lack of attention to employment (especially informal employment) in poverty reduction strategies and point to the links between being informally employed, being a woman or a man, and being poor. The book draws widely on recent data and evidence of the global research policy network called Women in Informal Employment: Globalizing and Organizing (WIEGO) as well as the knowledge and experience of the grassroots organizations in the network. Liberally scattered with practical examples, it provides a convincing case for an increased emphasis on informal employment and gender in poverty reduction strategies, and sets out a strategic framework for policy makers.
