# "LEGACY MOTHER TERESA" ACKNOWLEDGMENTS GIVEN OUT



The world looked upon Mother Teresa with enthusiasm, upon her sacrifice and devotion to the sick and the hungry, the lonely and the abandoned ones. The recognition to this mother, the Nobel Prize of Peace, came about in 1979. In that honour and in the honour of the seven past years since the death of Mother Teresa, a ceremony was held at the Macedonian Academy of Science and Arts, on 5 September 2004.

At the ceremony organized by the association "The Skopian Mother Teresa", the Mayor of Skopje Mr. Risto Penov

presented this year's acknowledgements to Mr. Boris Trajkovski (posthumous), Age Bojadziu and the Macedonian Centre for International Cooperation (MCIC).

Mr. Azis Polozani, Minister of Education and Science granted statuettes with the image of the big woman, to Miftar Miftari, Mitko Tosev, Skender Kuli, Galaba Zareska and the Nursery for elderly people "Mother Teresa".

The citizen of the world, Mother Teresa, was born 26 August 1910 in Skopje. She left her hometown on 26 September 1928 to dedicate herself to the humanity, to commit herself to the sick and the helpless. She passed away on 5 September, 1997 in Calcutta, India. The Pope Joan Paul II beatified Mother Teresa on 19 October 2003, that is to say proclaimed her Blessed – a preliminary step towards her sanctification.

# PROJECTS OF THE CIVIC ORGANIZATIONS IN MACEDONIA

On 23 September in Skopje, the Macedonian Centre for International Cooperation (MCIC) promoted the publication "Projects of the civic organizations in Macedonia". It con-'tains information about some of the projects implemented by the civic organizations in the period 2002/2003.

The publication singles out 658 projects (with a budget higher than 150.000 MKD)

out of the existing 5.312 registered civic organizations, which are included in the Address Book published by MCIC. The data in the publication have been gathered with the help of pollsters, who were operating on the whole territory of Macedonia.

The publication offers answers to the questions: what is the work of the civic organizations, who are the beneficiaries of their ac-

tivities, what is the cost of the activities, but also, what is the number of the people engaged in the implementation of the activities, or the number of the direct beneficiaries of the completed projects.

The analysis have indicated that, by virtue of type of activities, 67% are on informing and lobbying, 17% on training and 15% other. The activities have mostly been directed at 3 types of beneficiaries – people with special needs, women, children and young people.



# SEMINAR UNDER THE TOPIC "INTER-RELIGIOUS DIALOGUE"

OHE-day seminar under the topic "Inter-religious dialogue" was held on 13 of November 2004, organized by the Macedonian Center for International Cooperation (MCIC) in cooperation with the Orthodox Faculty "St. Clement of Ohrid" and the Faculty of Islamic Studies – Skopje.

The lectures at the seminar were given by Lisi Rasmusen and Safet Bektovic from the Islamic-Christian Study Centre in Copenhagen – Denmark, as well as by Professors from both of the Theological Faculties. The premises of the Faculty of Islamic Studies (FIS) were used to host the opening of the seminar and the premises of the Orthodox Faculty (OF) for the closing part of the seminar.

The Faculty of Islamic Studies (FIS) was the host of the morning working session. The Dean of FIS, Dr. Ismail Bardhi and the Vice-Dean of OF, Dr. Jovan Takovski delivered greeting and introductory speeches.



The Dean, Dr. Ismail Bardhi welcomed the guests and opened the seminar with the following words: "Coming to face this topic requires not only love and morale, but also a responsibility towards the religious culture in the multi-confessional society. In quite short time, we have proven that we know how to cooperate, despite the difficulties. Both of the Theological Faculties, the Islamic and the Orthodox, have proven to be ready to expand the mutual cooperation when it comes to preserving the purity

of the faith and upgrading the religious culture."

In his greeting speech, Dr. Jovan Takovski pointed out: "This gathering represents one more chance for us to seek out ways and forms for future mutual cooperation with an aim of upgrading our relations at the Faculty level, however to make a contribution towards upgrading the relations between our peoples too."

Panel discussion under the topic "The nationality in a pluralistic society – the relation between the state on one side and the churches or the religious communities on the other side (different types of secular societies)" was also held.

The afternoon working session of the seminar went on in the Orthodox Faculty with the lecture by Lisi Rasmunsen "Why interreligious cooperation?" In her lecture, she pointed out "Having been religious people, individuals and communities, we have theresponsibility to work for the common good, against the use of the religious identity as antagonism to the others."

Following the lectures, a presentation on the topic "How can the Christians and the Muslims communicate and work together?" was organized. The lecturers from Denmark, Lisi Rasmunsen and Safet Bektovic, presented their experiences from the work in the Islamic-Christian Study Centre. The Macedonian experiences were presented by Aco Girevski in his expose "Christianity and Islam".

The seminar was followed by large number of students and professors from both of the Faculties and guests from the churches and the religious communities in Macedonia.



The Macedonian Centre for International Cooperation conducted a training on strategic planning, from 21 to 24 September this year, in Ohrid. The goal of the training was to empower the civic organizations with the management skills necessary for the development of the capacities of the civic organizations and their upgraded functioning. The absence of strategic plan in the management of the organizations is the major negative aspect. This particularly pertains to the newly formed organizations, where the need for strategic planning is not fully developed yet.

There were 16 activists from four civic organizations, each organization delegated four participants, who took part at the training. The training was delivered by Liljana Alceva and Neda Maleska-Sac-maroska, trainers from MCIC.

On the 8<sup>th</sup> meeting, on 21 September 2004, the MCIC's Governing Board sanctioned the text of the MCIC's Statute and adopted the proposals on alteration and suspension of the Statute of the counseling organizations.
